In March 2015 in Colombo, Sri Lanka, during the 1st Annual World Conference on Women's Studies organized by TIKM in Sri Lanka, conference participants established the World Center for Women's Studies (World-CWS) as an organization intended to serve and benefit men and women, and women's organizations that provide service, research, and support to women's empowerment worldwide. She is the Founding Chair of the Department of Global Gender Studies at the University at Buffalo and a former faculty member and the Director of Academic Programs at Cornell University. She is the author of ten books and nearly 70 scholarly articles and chapters in academic books. Her research concerns are the worldwide diffusion of democracy, and the effects of democratization on the well-being of societies, especially on women and girls. Her teaching interests includes sociology, gender justice, environmental justice, global democracy, and development.

The global crisis brought about by the COVID-19 pandemic is reshaping the world. The pandemic is slowly worsening the darker aspects of socio-economics and gender equity has suffered a brutal blow amidst the crisis. During this pandemic, women and girls may be at higher risk of intimate partner violence and other forms of domestic violence due to increased tensions in the household. With women representing a majority of the health and social sector workforce globally, special attention should be given to how their work environment may expose them to discrimination, as well as their sexual and reproductive health and psychosocial needs as frontline health workers. Moreover, the closure of schools and workplaces, and older relatives possibly getting sick, is likely to cause their unpaid workload to further increase. Understanding this situation, leaders, policy makers and other parties should play their role to minimize the damage on the delicate balance caused by the pandemic.

Mr. Geoffrey Harris is currently the Deputy Head of the European Parliament Liaison Office with the US Congress and formerly Head of the Human Rights Unit within the Secretariat General of the European Parliament (Directorate General for external policies DGEXPO). This unit provides the back-up for the sub-committee, a parliamentary body working in the framework of the Foreign Affairs Committee of the European Parliament. The unit provides back-up for all initiatives and aspects of the work of the institution concerning human rights (the President, the Development and External Trade committees and the Inter parliamentary delegations). Mr. Harris has been an EP official since 1976 and previously was in charge of the European Parliament's delegations dealing with EU enlargement and relations with other neighboring countries.

In my keynote I will link the themes of your conference to the wider issue of the culture wars going on in modern politics and in society. I will mention current events in the US but set them in a wider historical and global context.

Since the end of the Cold War in 1990 the focus of political life in many western countries has shifted from the economy to identity. In 1992 Bill Clinton was elected President telling his team that the decisive issue would be "the economy, stupid." In 2016 Hillary Clinton lost a Presidential election to a candidate talking of solving the economic problems of the left-behind but galvanizing them with the language of culture wars.

This conference will address gender equity in the context of the global environmental crisis. It will look ahead to the post-Covid world. It would be overly simplistic to see all these trends as totally linked, let alone to assume collusion or

conspiracy between those with converging views in different places (UK leader is pro-Brexit and attacks the liberal elite but does not deny climate change or undermine abortion rights). Poland's leaders do not challenge EU membership but do challenge abortion and gay rights and was considering withdrawing from the Istanbul Convention on domestic violence. The post-Covid world is, however, already visible, even as the pandemic remains largely unabated. It will be a world in which negative trends in terms of gender equity and environmental catastrophe are set to be enhanced. Denial of the scientific truth on ecological and health issues is central to current realities. The enrolment of religion as part of an ongoing culture war is facilitated by leaders and movements trying, and too often succeeding, in obliging citizens to make a choice between their religious faith and scientific reality. Covid will just go away, the fires will just die down. The melting ice-caps are just incidents, not part of any trend.

In spite of the dramatic nature of current events and the particular tensions of the US election it is vital to see things in a wider context.

- Culture wars distract from real political choices. They confuse and weaken those with less power to shape the way choices are approached.
- Culture wars were initiated in modern US politics by the Reverend Pat Buchanan in the 1992 Presidential election.

The phrase "culture war" refers to the German Kulturkampf, namely the clash between cultural and religious groups in Germany on the 1870s when Bismarck was challenging the influence of the Catholic Church. In America in the 1920s urban and rural American values came into conflict as society responded to decades of immigration to the States by people who earlier European immigrants considered "alien." Sloganeering about "America First" and anti-Semitism emerged as strong influences at that time.

- Denial of climate change is just one element in the ongoing culture war against science. Climate change deniers often align with vaccine deniers those denying growing social inequality and playing up divisions in society. Development assistance has often included specific support for women's health and girls' education.

Feminism has gone through a long history of struggles and successes. The Philippines, as a developing country, also has a story to share in its struggle for gender equality and equity. This presentation aims to elucidate the evolution of feminism in the Philippines, and the significant accounts in its history that have influenced the strengthening of women agenda and women empowerment in the country among women's organizations, legislations, the academe and the like.

While it is recognized that more needs to be done in reaching the goal for gender equality and equity, the women movement in the Philippines has accomplished much in awakening women awareness of their situation and socialization, in putting the women agenda in the government institutions and in the NGOs, in having the most friendly legislations, in successfully campaigning for the defense of women's rights in making possible that the Philippines is the only country that mandates gender streaming in the academe in making possible the prosecution of sex perpetrators against women and children.

ignited with the emergence of social movements. Steeped in socio-cultural underpinnings from the Civil Rights Movement, the nation has seen protests for racial and gender equality manifest on a new level of community mobilization. The resurfaced trauma that has been experienced over several generations has shed light on the intersectionality of systematic oppression that has been built institutionally and individually. From mass incarceration, police brutality, inequity in the education system, and the disproportionate rate of women in high-level roles in senior cabinet positions; this moment in time has been pivotal to how we lead with solutions as leaders in our communities. With this year marking the 100th year anniversary of the 19th Amendment, a policy known to have given women the right to vote; but missed the mark on the inclusion of women of color. The path to equality and equity has been a rocky one. This paper discusses the ways in which we, as community activists can move forward in practical ways to un-write systematic structures and rebuild an inclusive community that goes beyond policy but re-creating a way of life that breaks down barriers to access, equity, and equality.

Women vs. Global Information Technology

According to World Bank (2020), the number of men and women is roughly equal, though men hold a slight lead with 102 men for 100 women (in 2020). More precisely, out of 1,000 people, 504 are men (50.4%), and 496 are women (49.6%). Our way of life has drastically shifted during the last several decades due to Information Technology (IT). Today, many people use IT for their daily work, education, shopping, travel, exploration, banking, manufacture, security, development, communication, networking, and social connection. (STEAM) from the classroom, workplace, and kitchen space. One way to accomplish "women's empowerment" and "sustainable development" is to adopt innovative approaches to bridge women in shared governance to sustainable development programs and provide IT equity.






